Section 3. Truncation of Existing Commissioner Terms. For service areas that exist as of the effective date of this ordinance, the terms of all commissioners and alternate commissioners will be truncated to expire on June 30, 2021. Commissioners will then be reappointed and draw lots in accordance with FNSBC 14.04.110, in order for terms to be staggered.

Section 4. <u>Effective Date.</u> This ordinance is effective at 5:00 p.m. on the first Borough business day following its adoption.
