ORDINANCE PROPOSING A SERVICE AREA ELECTION

ORDINANCE NO. 2022-55. An Ordinance Altering The Boundaries Of Potlatch Service Area To Include Lots 11-14 Block C, Lots 1-5 Block E B&A Subdivision; Lots 1-13 Benson's Subdivision; Lots B-1A – B2 Secretariat Subdivision 1st Addition; And TL-2306, TL-2404, TL-2507, TL-2510, TL-2616, And Providing For Two Elections. (Sponsor: Mayor Ward)

PUBLIC HEARING

This ordinance is scheduled for Public Hearing on **Thursday, October 13, 2022** at or after 7:00 p.m., in the Mona Lisa Drexler Assembly Chambers, 907 Terminal Street, Fairbanks, Alaska. If the ordinance is adopted, an election will be held on Tuesday, November 15, 2022.

VOTING IN THE SERVICE AREA ELECTION

If the ordinance is adopted, an election will be held on Tuesday, November 15, 2022. **Ballots are not automatically mailed.**

TO VOTE:

- Vote in person at the Clerk's Office beginning October 19, 2022 through Election Day, Tuesday, November 15, 2022 (excluding weekends and holidays) from 8 a.m. to 5 p.m.; or
- Apply for an absentee ballot to vote by mail or electronic transmission.

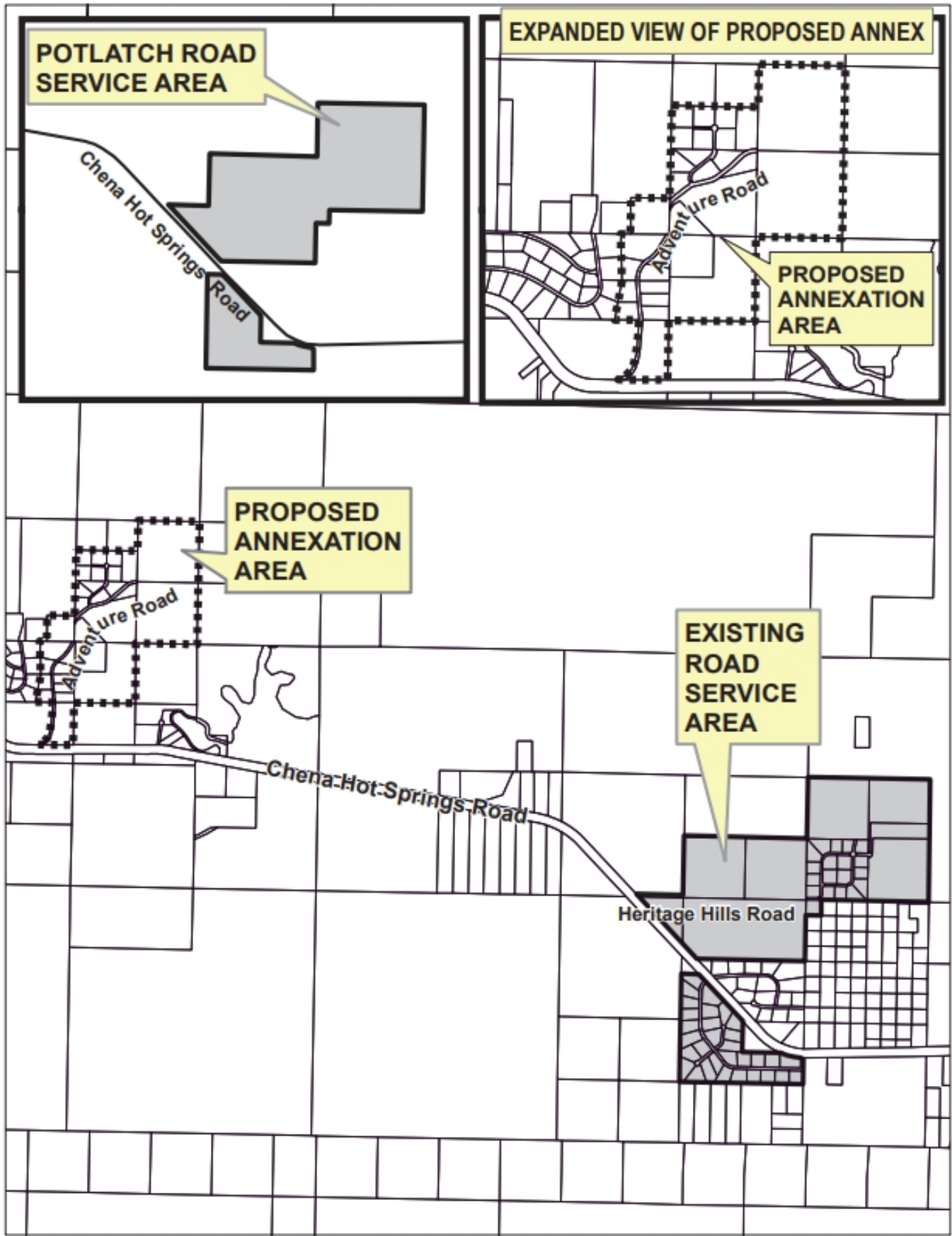

VOTER QUALIFICATIONS

You must be a resident and registered to vote at an address within the Potlatch Service Area or proposed annexation area at least thirty days prior to the election.

If the ordinance is adopted, an election will be held on November 15, 2022 to place before the registered voters residing within the Potlatch Service Area and the registered voters residing within the proposed annexation area the following question: "Shall the boundaries of Potlatch Service Area be altered so that the Borough may exercise road maintenance and construction powers within the area indicated on the attached map?"
