GENERAL INFORMATION

Municipal elections are held annually the first Tuesday in October to elect approximately one-third of the FNSB Assembly, School Board, and City Councils for the City of Fairbanks and City of North Pole Two at-large seats of the Interior Alaska Natural Gas Utility Board (IGU) are elected every year, except for every third year in which three board members are appointed by the Mayors of the Borough and Cities of Fairbanks and North Pole. The Municipal Mayors are elected every three years. The Borough Clerk's Office processes all absentee ballot requests for the Fairbanks North Star Borough, City of Fairbanks and City of North Pole. Run-off elections and special elections are held as needed or when called by the Assembly or Councils. In the event of a run-off or special election, each municipality is responsible for conducting that election.

You may apply for an absentee ballot(s) for any or all elections conducted by the Borough within the calendar year as long as the ballots for each election are sent to the same address. Note: Primary, general, and federal elections are conducted by the State of Alaska. To vote absentee in those elections, apply directly to the Alaska Division of Elections, Absentee Voting Office, 519 E. Ship Creek Ave., Suite 329, Anchorage, Alaska 99501-1677.

If you are in the Fairbanks North Star Borough within 15 days before the election, you may vote early or vote absentee in person. You do not have to complete this application to vote early or vote absentee in person.

*ALASKA CONSTITUTION, ARTICLE V, § 2

§ 2. Disqualifications

No person may vote who has been convicted of a felony involving moral turpitude unless his civil rights have been restored. No person may vote who has been judicially determined to be of unsound mind unless the disability has been removed.
